4. The Trustee

The Declarant shall be the Trustee of this trust for life. When he finds it impossible or inconvenient to continue as Trustee he will nominate any other proper and fit person to succeed him and such nominated Trustee shall assume charge as Trustee with full powers invested on the Trustee under this deed or as may be directed by the present Trustee.

- 5. Functions of the Trustee
- (a) General administration of the affairs of the Trust.
- (b) Appointment, discipline and dismissal of staffs and workers of the Trust.

- (c) Maintaining all correspondence of the Trust, both outward and inward.
- (d) Preparing the various projects and programmes of the Trust.
- (e) Operating on the bank accounts in the name of the Trust.
- (f) Receipt and expenditure of the Trust and maintaining all accounts and books.
- (g) Carrying on of all activities of the Trust.
- (h) Representing the Trust in all civil Criminal and Revenue courts and all the offices, of the Government and Quasi Government.

6. Advisory Committee

The trustees may constitute a Committee called "Advisory Committee" consisting of not more than 5 members to help the Trustee in the administration of the affairs of the Trust. The members of the committee shall be nominated by the Trustee. Any member whose conduct is not conducive to the objects of the Trust, may be expelled from the Committee by the Trustee. The term of office of the committee members shall be 3 years.

7. (i) The Advisory Committee shall be convened by the Trustee whenever it is found necessary. The Trustee shall preside over all the meetings of the committee. The Committee shall be an advisory body without executive powers.

(ii) The proceedings of the committee shall be recorded by the Secretary in a Minute Book and signed by the Trustee.
No quorum is fixed for the meetings of the committee.

8. Accounts of the Trust

- (i) Proper accounts and other books shall be maintained and entries of all receipts and expenditure entered therein accurately and punctually.
- (ii) The Trustee is responsible for the receipts and expenditure of the Trust and maintaining the accounts.

9. Financial year of the Trust

The financial year of the Trust shall be from April 1st to March 31st At the end of each financial year the accounts of the Trust shall be closed and a statement of Receipt and Expenditure and a Balance Sheet prepared and got audited by a qualified Auditor and signed by the Trustee.

10. Appointment of Secretary

- (i) To make easy the administration of the affairs of the Trust, the Trustee may appoint a paid Secretary with necessary qualifications. The Secretary shall work and function under and as directed by the Trustee. The pay and allowances of the Secretary shall be fixed by the Trustee and paid from the funds of the Trust.
- (ii) The Secretary may be dismissed without assigning any reason, when his action is not conducive to the objects of the Trust or when his services are no more required.

11. Funds and finance of the Trust

The following shall be the funds of the Trust.

- (i) Amount donated and to be donated by the Trustee.
- (ii) Amounts and things donated by other well wishers and philanthropists.
- (iii) Help and aid and subsidies and grants from Government and other institutions and organisations.
 - (iv) Other income and interest on investment.

12. Power to amend the terms of the Trust deed

The Trustee may amend alter, add or delete any of the terms and conditions contained in this trust deed.

13. Action to be taken on the failure of the Trust

If for any reason, the trust could not be continued, the assets and liabilities of the trust shall be transferred to any other Trust or Organisation having like objects or the Trust may be dissolved and the proceeds applied for similar objects.

14. Donation by the Trustee

The Trustee has donated a sum of Rs.1,000/- which shall be the present fund of the Trust.
